All concerned candidates are hereby informed that in compliance to the judgment of the Hon'ble Supreme Court of India in:

Civil Appeal No. 10262 of 2025

The West Bengal State Electricity Transmission Co. Ltd. & Ors. vs. Dipendu Biswas & Ors. 2026
INSC 330 Judgment dated 07.04.2026,

All allotments done for PwBD/PwD candidates in the Provisional Allotment list 14.09.2026 (MBBS & BDS Admissions - 2026, Round 2) are declared "NULL and VOID" (ONLY FOR PwBD/PwD CANDIDATES).

In light of above said judgement the Provisional Allotment list of Round 2 is being revised herewith.

REVISED PROVISIONAL ROUND 2 PwBD/PwD CANDIDATES SEAT ALLOTMENT RESULT

Revised Provisional Round 2 Seat Allotment Result, ONLY FOR PwBD/PwD candidates, for Rajasthan NEET UG Counselling 2026 is being issued in view of the principles laid down by the Hon'ble Supreme Court of India regarding the manner of application and adjustment of horizontal reservation for Persons with Disabilities (**PwD/PwBD**).

The revision is being undertaken with reference to

1. Scope of the Revised Result

- a) The Revised Provisional Round 2 Result issued pursuant to this Notice relates specifically and exclusively to **PwBD/PwD candidates**.
- b) The revision has been undertaken for the purpose of applying the applicable horizontal reservation and merit-based adjustment principles to **PwBD/PwD** candidates, in accordance with the applicable Rajasthan NEET UG counselling framework, reservation provisions and the aforesaid judgment, to the extent applicable.
- c) This Notice and the revised result shall not be construed as a general revision of the Round 2 result for candidates other than **PwBD/PwD candidates**.
- d) The revised allotment, wherever applicable, may result in a change in the **category/quota and college against which a PwBD/PwD candidate is allotted**, and/or consequential revision of allotment including fresh allotments as reflected in the revised result, in accordance with the applicable seat matrix, merit, eligibility, choices and reservation provisions.

2. Round 2 Joining – PwBD/PwD Candidates

All candidates who have been allotted a seat in the Revised Provisional Round 2 Result are required to report at SMS Medical College, Jaipur, for completion of the prescribed Round 2 joining/admission formalities on **20.09.2026 till 05:00 PM**. However, downloading of Revised Provisional Allotment letter of Round 2 shall be available **only till 4 PM on 20.09.2026**. **Candidates are advised to download their allotment letter within the stipulated time period (Deadline–4 PM on 20.09.2026). After which it shall be disabled to facilitate further process.**

CANDIDATES WHO HAVE ALREADY DEPOSITED THE FEE NEED NOT DEPOSIT AGAIN.

3. Provisional Nature of Revised Result

The Revised Round 2 Result is **provisional and indicative in nature** and is subject to:

- verification and scrutiny of eligibility;
- verification of PwBD/PwD status and supporting documents;
- verification of category, reservation and domicile status, wherever applicable;
- verification of NEET merit/rank and qualifying eligibility;
- reconciliation of candidate data and seat matrix;
- correctness and validity of documents and information furnished by the candidate;
- application of the applicable counselling rules and reservation provisions; and
- any subsequent Government/competent authority notification, clarification, direction or order of the Hon'ble Courts.

4. Reservation, Merit and Consequential Revision

The Board shall apply the applicable horizontal-reservation provisions **in conjunction with the relevant vertical/social reservation provisions and merit**, as applicable to the Rajasthan NEET UG counselling process. Accordingly, any allotment requiring consequential revision upon application of the applicable reservation framework may be revised by the Board. **No candidate shall claim an indefeasible right to retain an earlier allotment merely because such allotment appeared in an earlier provisional result.**

5. No Vested Right from Earlier Allotment

Publication of the earlier Round 2 allotment result dated 14.09.2026, issuance of an allotment letter, payment of fee, reporting or provisional joining **shall not, by itself, confer a vested, absolute or indefeasible right to a particular seat, college, category/quota or continuation of admission**, where subsequent verification, reconciliation, application of the applicable reservation framework or a competent authority/Court direction requires consequential revision.

6. Verification and Cancellation

The Board reserves the right to **verify, scrutinise, reconcile, modify, revise, withdraw or cancel any allotment or admission**, wholly or partly, at any stage, if:

- the candidate is found ineligible;
- the PwBD/PwD status or supporting documentation is not established as required;
- any document/information is found incorrect, incomplete, invalid or misleading;
- any discrepancy is found in category/reservation/merit/seat-matrix data;
- any technical, clerical, computational or administrative error is identified;
- any subsequent verification or reconciliation necessitates correction; or
- such action is required pursuant to any applicable rule, Government/competent authority direction or order of the Hon'ble Court.

Any consequential vacancy arising from revision/cancellation shall be dealt with **strictly in accordance with the applicable counselling rules and the seat matrix prevailing for the relevant round.**

7. Compliance with Court/Competent Authority Directions

This Notice and the revised result shall at all times remain subject to **applicable statutory provisions, regulations, Government notifications/orders, directions of the competent authorities and orders/directions of the Hon'ble Supreme Court/High Courts or any other competent judicial forum.**

In case of any subsequent judicial order, Government notification, regulatory clarification or competent-authority direction affecting the subject matter, the Board shall be entitled to take consequential action and revise the result/allotment accordingly.

8. Responsibility of Candidates after declaration of Revised Round 2 Result for PwBD/PwD

Candidates are advised to:

- check the revised result carefully;
- download the revised allotment letter, within the stipulated time period;
- comply with the prescribed reporting/joining timeline;
- re-report if they have already joined;
- keep all original documents and required copies readily available; and
- document deposited earlier shall be available with the respective colleges and if needed will be transferred from one college to another.
- regularly monitor the official counselling website for further instructions.

No individual candidate shall be entitled to claim extension of the prescribed deadline merely on the ground of failure to check the website, non-receipt of a telephonic call/message, technical difficulty at the candidate's end, or any other circumstance not attributable to the Board.
