(STATE OF RAJASTHAN)

In compliance to the state schedule for Round 3 for NEET UG 2026, released by MCC, the Round 3 of NEET UG Medical /Dental Counselling 2026 for State of Rajasthan is being scheduled as below:

SCHEDULE (Round-3)

<u>Application form (Registration) by fresh candidates by completing both the parts of the application form</u> Start date for filling of on-line application form and deposition of required application fee It is a mandatory step for subsequent process. * Both the parts (Part 1 and Part 2) of the application form must be filled and completed ALREADY REGISTERED CANDIDATES NEED NOT REGISTER AGAIN CANDIDATES REGISTERED IN ROUND-1 & 2 WHO HAVE NOT COMPLETED PART-2, MAY COMPLETE IT NOW Note: A candidate allotted/upgraded a seat in round 2 of counseling and has not joined/not reported the allotted seat (security amount forfeited) and wishes to participate in round 3, must re-register / fill fresh application, deposit required application fee and deposit the security amount again, as applicable. Candidate who is not covered under the clauses from I to X of other eligibility criteria but falls under clause XI is also required to fill the application form / register (non-domicile out of Rajasthan state candidate)	23.09.2026

Seat (MBBS course) in Government Medical Colleges, Govt. Society Medical Colleges, RUHS CMS and ESIC MC Rs. 2,00,000/- for candidate opting for Management Seat (MBBS Course) in Govt. Society Colleges and RUHS CMS Rs. 5,00,000/- for candidate opting for NRI Seat (MBBS Course) in Govt. Colleges, Govt. Society Colleges and RUHS CMS Rs. 5,00,000/- for candidates opting for MBBS Course in Private Medical Colleges [Candidates depositing Rs. 2,00,000/- or 5,00,000/- will automatically be eligible to fill choices for Government Medical / Dental Colleges, Govt. All newly registered / re-registered candidates willing to participate must deposit the applicable security amount. Candidates who deposited the applicable security amount in Round 1 / Round 2 (except candidates whose security deposit was forfeited due to non-joining in Round 2) are not required to deposit it again but those candidates who did not deposit the applicable security amount in Round 1 / Round 2 or wish to deposit the applicable difference amount (based on type of seat/course/college) must deposit it now (as the case may be) on-line, failing which they will not be considered for allotment on a seat/seat type in a college. All candidates who did not report on Round 2 allotted seat must re-registered and deposit security amount again for participation in Round-3.	
Choice filling On-line Choice filling (including filling up and saving of the choices / changing the filled choices multiple times) Note: Choices filled by the candidate in Round 1 / Round 2 will not be considered for Round 3 allotment. Following candidate who wish to participate in Round 3 must fill choices: 1. Registered candidate who did not get allotment in Round 1 / Round 2 2. Registered candidate having 'Joined' status and is willing to upgrade 3. Registered candidate who got allotment in Round 1 and resigned without forfeiture of security amount (who resigned upto 16.09.2026 upto 5.00 pm) 4. Newly registered candidate 5. Re-registered candidate 6. Candidate who falls under clause XI "Other" of Other Eligibility Criteria (All India candidates) [to be considered for allotment against vacant seats available after exhausting State Merit list of candidates of clauses I to X] Note: Candidate having Joined status (upto Round 2) and does not wish to upgrade and wishes to retain his/her seat need not fill choices in Round 3. Candidates participating in round 3 must fill choices keeping in view the virtual vacancies that may arise due to upgradation of a joined candidate of earlier round and vacancies available due to exhaustion of NRI/ PwBD/PwD / Category candidates <i>*The projected seat matrix after allotment and joining of Round-2 is reflecting only real vacancies. However, virtual vacancies may arise and convert to real vacancies during allotment process and vacancies may also arise due to resignation after Round 3 result of MCC. Candidates are advised to fill choices considering both real and virtual vacancies. 1. Refer information bulletin, college information sheet and college fee structure etc. and other information at the website. Regarding fee, also refer order dated 19.05.2022 of Hon'ble Supreme Court in civil appeal no. 3978-3995/2017.
2. Detailed programme for further rounds will be announced later on website.
3. All Defence/Para Military and NRI candidates must present themselves physically for certificate verification before the admission board on 05.10.2026 (10:00 AM to 3:00 PM) as per the notification.
4. All fresh candidates are required to deposit non-refundable application fee of INR 2500/- (INR 1500/- for SC, ST, ST-STA category candidate of Rajasthan state domicile) + applicable transaction charges. **(already registered candidates need not apply/deposit registration fee again).**
5. All PwBD/PwD candidates who wish to participate are required to upload their Eligibility Certificate issued from the MCC designated center (MCC designated centers as per list available on MCC website). For this, visit the MCC website (mcc.nic.in) regularly. Participation as PwBD/ PwD candidate shall be subject to online verification of the uploaded Eligibility certificate. The candidate must bring the original eligibility certificate along with other original documents at the time of joining/reporting.

6. Part 2 and Part 1 (partially) of the application form is editable and candidate can edit until final submission at 10:00 PM on 03.10.2026. Fresh and already registered candidates can apply for **change/correction (including caste and additional category) in filled part 1 from 23.09.2026 to 03.10.2026** by sending duly signed hand written application along with self-attested photocopy of relevant documents from their registered mail id to support mail id available on website. (support@neetrajasthan.com)
7. A candidate allotted a seat (fresh / upgraded) in round 3 of counseling and does not join the allotted seat, his/her security amount will be forfeited. Such candidate shall not be eligible to participate in further round.
8. Candidates having joined status after round 3 will not be allowed to participate in further round.
9. Candidate who joins the course on allotment of round 3 counselling or retains his or her seat (allotted in earlier round) in Round 3, shall not be allowed to resign the course (including returning of original documents) on or before the last date of admissions as scheduled by MCC/NMC/DCI and conditions of bond shall be applicable.
10. The candidates are advised to visit the website regularly for all relevant information and latest updates.

Important:

- **For candidates willing to participate/upgrade in Round 3, it is mandatory to fill fresh choices in Round 3 (irrespective of whether the candidate was allotted/joined a seat in Round 1 / Round 2 or not).**
- **The choices filled by a candidate in Round 1 / Round 2 shall be scraped and will not be considered for Round 3. If a candidate does not fill fresh choices for Round 3 then he/she will not be considered for allotment / upgradation in Round 3.**
